Opening the polls

- 1. When setting up the polling place room/area, which of the following factors need to be considered:
 - a. Traffic Flow
 - b. Voter Privacy
 - c. Access
 - d. All of the Above

2. TRUE or FALSE?

All judges must take the oath and sign the Official Precinct Certification Form, regardless of what shift they are working.

3. TRUE or FALSE?

You need to use two (2) ballot to test the Assisted Ballot Marking Device in the morning – insert one ballot in the device to compare the order of offices and candidates on the other ballot.

- 4. If the "Public Count" on the ballot counter is any number other than 0 when you turn it on in the morning, you should:
 - a. Proceed as normal
 - b. Put that number of ballots in the ballot box
 - c. Contact Election Headquarters immediately for guidance
 - d. Postpone the opening of the polling place

5. **TRUE** or **FALSE**?

When comparing the ballot and the Zero Tape, the offices and candidates must match in both order and in spelling.

General rules & procedures

1. TRUE or FALSE?

In the polling place, we must assume that a voter's perception is their realty.

2. **TRUE** or **FALSE**?

A voter can wear campaign materials tied to a party, candidate, or issue/question that is NOT on the ballot.

- 3. Party balance is required for all of the following polling place tasks except:
 - a. Curbside voting
 - b. Inititaling unmarked ballots
 - c. Duplicating ballots
 - d. Emptying the ballot box
 - e. Helping a voter with marking their ballot
- 4. When are news media permitted in the polling place?
 - a. Between the hours of 9 am and 3 pm
 - b. Any time during polling place hours, as long as they have a written letter of permission from election officals
 - c. Any time during polling place hours, as long as they present their media ID and credentials to the Head Judge

Greeter Judge

- 1. As the Greeter Judge, you should (select all that apply):

2. The Greeter's List contains

Poll Book Judge (Registering voters)

1. **TRUE** or **FALSE**?

You should manually enter street addresses when registering voters on the poll book.

- 2. If a registered voter in the precinct moves to a new address in the precinct, or changes apartment/unit numbers at the same street address, what is the simplest proof of residence option they can use?

Challenges

- 1. Who can challenge the eligibility of a voter to vote in the precinct?

Demonstration Judge

Ballot Judge

Ballot Counter Judge

1. TRUE or FALSE?

If a voter brings in an absentee ballot that was mailed to them, you should allow them to vote that ballot and deposit it into the ballot counter.
